#### Operating Instructions

Mix A and B separately. Heat up both to 80°C. Add B to A and homogenize for 5 minutes. Cool down while stirring and add C below 35°C. Adjust pH value to 7-7.2 with D. Add E as desired and F with moderate stirring.
